Our club was organized in August 1948. We are incorporated as a non-profit organization. We have a 501-C-3. This instrument is for the purpose of building an endowment fund for carrying on our conservation work. Gifts to this corporation are tax deductible and are always welcome.

### What do we have to offer you?

As a conservation club, we have numerous interests. Our environmental activities include tree planting, water and soil conservation, pollution concerns, wildlife management, and the preservation and creation of wetlands habitat. Our club has purchased property and is developing a wetlands project known as the "Dr. L.J. Darr Memorial Wetlands Project."

Our members are involved in these additional activities:

- construction of duck and bluebird boxes;
- archery instruction (usually beginning in January);
- providing free hunter education courses;
- providing personal protection courses;
- providing NRA instructor qualification courses in rifle, pistol, and shotgun;
- practice and/or competition with pistol and small bore rifle in indoor range for both Junior and Senior level participants;
- hunting of small game;
- fishing education---
- water safety

We are a National Rifle Association Club and work closely with the Ohio Department of Natural Resources. We are also members of the Ohio Rifle and Pistol Association and the Ohio League of Sportsmen.

Our club meets on the second Monday of each month at 8 P.M.; the trustees meet at 7 P.M. We invite your participation as a member of our conservation club. The club is located at 975 South Gordon Road (off CR 18) in Oak Harbor. Applications for membership are available at our meetings and also available from any club member.

**All memberships are voted on at our monthly meetings, if your application is received after that month's meeting , it will not be voted on until the following month.**

As of this writing, our annual dues are \*\$75.00, with a one-time initiation fee of \$20.00 and an \*\*Upland Game Hunting annual user fee of \$30.00 .

Our clubhouse has installed electronic door locks. Key fobs are \$20.00 each, which will be reimbursed when it is surrendered. However if your fob is lost, a replacement will be an additional \$20.00. Those members wishing to have access to the Gordon Road Clubhouse and/or to be checked out for the indoor ranges may come on the last Monday of the month (unless its a holiday) at 7 P.M.
